ABSTRACT Cider is one of the main products of apple processing. Aroma makes important contribution to the flavor of cider. 我国浓缩苹果汁出口占国际市场三分之一

果汁进出口形势如火如荼,2001年,我国出口水果汁共16.4989万t,2002年1~6月,共出口水果汁12.2134万t,创汇8413万美元,其中浓缩苹果汁出口为11.9431万t,同比增长了76%左右,其占整个果汁出口市场份额的97%。目前,我国浓缩苹果汁已在国际市场上占有三分之一的份额。
